### **PURPOSE OF RESEARCH POLICY:**

The purpose of Research policy is to create a vibrant atmosphere of Research amongst the faculty members and students. The policy will serve a framework for conducting Research work. This will provide thirst area of Research and its social relevance. The Research policy may contribute significantly towards society and the nation at large.

### **AIMS OF THE RESEARCH POLICY:**

1. Research policy of the college aims to create a research ambiance among its faculties and students and leverage it for enriching the professional competence of the faculty members and students.
2. Realizing the vision and missions of the college.
3. Establishing an institutional fund for facilitating resources for Research work.
4. To enhance research capabilities, collaborations, and output.
5. To develop conducive environment for conducting Research, extension, and knowledge development.
6. Encoring publications in high impact quality journal.
7. Establishing standards relating to safe and ethical conduct of research.

### **SCOPE FOR THE RESEARCH POLICY:**

The scope of this policy is defined to include:

1. All staff who are active in teaching, research, administration, and provision of any form of support to the core functions of the college.
2. All students registered with the college in the Ph.D.program.
3. All mentors, guides, external experts, and sponsors associated with any of the research activities of the college.
4. All academic and administrative departments of the college

For regulating Ph.D. research work, college has constituted a DRC committee to facilitate the research work as per UGC and University regulation.

### **COMPOSITION OF DRC COMMITTEE (Departmental Research Committee)**

The Research Degree Committee shall consist of the following:

- **Principal – Chairman**
- **Concerned Head of the Department - Member**
- **Supervisor, and Co-Supervisor** (if any) of the concerned Ph.D. Scholar – Member(s)
- All registered supervisor is the department member.

#### **Functions of DRC Committee:**

- All the applications for admission to Ph.D. program are scrutinized by DRC committee as per the UGC regulation and Ordinance 45 of Pt. Ravishankar Shukla University.
- To suitable candidates, Supervisor/Co Supervisors are allotted as per the guidelines of UGC and Ordinance 45 of the affiliating University.
- Synopsis of Ph.D. work is submitted before the DRC committee for check, later forwarded to RDC committee for Registration.
- Ph.D. thesis before submission is presented before the DRC for correction and suggestion.
- All the matters related to Ph.D. research work are regulated by DRC.

#### **Code of Ethics for Research:**









- All students pursuing research in the college are expected to maintain honesty, integrity, and professionalism.
- An ethic committee has been constituted and a Standard Operating Procedures (SOP) is adopted for monitoring research activities of the college.
- Since the college is affiliated to Pt. Ravishankar Shukla University, Raipur, the college would follow the regulations of the University and U.G.C. regarding plagiarism and malpractice in research.
- A Ph.D./M.Phil. thesis submitted from the institution is screened by Pt. Ravishankar Shukla University, for plagiarism before it is accepted.

#### **Research Policy Implementation Mechanism:**

The Research Degree Committee of the college shall be responsible for implementing this research policy. The specific roles and functions of the research committee would be:

1. Facilitating the faculty in undertaking research and to set up a research fund for providing seed money.
2. Providing research facilities for- research journals, laboratory equipment and research incentives etc. required by the faculty.
3. Encourage and promote a research culture.
4. Facilitate collaboration with other research organizations/industry.
5. Encourage for the submission of Mini/Mega Research Project to various funding agency.
6. Facilitate faculty for the submission of proposal for the organization of Seminar/Workshop.
7. Promote to sign MOU with various institutions conducting Research.
